Enforcement Update

In 2024 the PSA commenced 805 enforcement cases to ensure compliance with the licensing regulations. We undertook 144 contractor inspections, carried out 231 unannounced compliance inspections on licensed premises, and investigated 217 buyers of security cases. We had 4 successful prosecutions.

Employment Letters

PSA licensed contractors may request an employment letter from the PSA for employees who have lodged an application but not yet been issued with a licence. Employment letters are currently valid for a maximum of 60 days, but this duration may vary depending on our processing times. Requests for employment letters should quote the name of the applicant and their PSA application number and be sent by email to <u>licensing@psa-gov.ie</u>. The employee should not commence licensable activity until they receive an employment letter.

It is an offence under Section 37 of the Private Security Services Acts to provide a security service without a licence. Contractors using unlicensed personnel may have their licence suspended or revoked.

Guide Dogs and Assistance Dogs

When providing security at shops, cafes, bars or restaurants please take account of the needs of people with guide dogs or assistance dogs. Remember that discriminating against people with disabilities is an offence under the Equal Status Acts. For further information visit the following websites;
